Thank you for forwarding the updated documentation.

The following advice is in relation to the report titled 'Response to Representations, Agency and Council Comments' by URPS and the associated revised documents for Development Application 24029287, forwarded on 17 December 2024. This email is to be read in conjunction with the original referral letter (dated 29 October 2024 – attached for information).

The following notable changes have been identified in relation to the Government Architect's referral advice:

- shrub and tree sizes increased within the landscaped area on the Northcott Terrace frontage (to the north of the retained hotel building)
- deep soil area to the perimeter of the site increased from 842 to 850 square metres
- openings to the communal corridor to the two-storey apartments increased in size and glazing replaced with open mesh
- further design development to the raised pool on the level 2 terrace, including the addition of a lift
- reflected ceiling plans provided to confirm the apartment ceiling bulkhead arrangements that ensures 2700mm ceiling height for habitable rooms
- 500mm deep recesses to apartment entry doors introduced on levels 3 to 9, with the intent to articulate the long corridors and create a sense of entry
- review/clarification of the external materials and provision of a physical material samples board.

It is acknowledged that the design changes/clarifications are generally positive, and the Government Architect remains supportive of the proposal.

In terms of the external materials, we recommend confirmation of the following:

- materiality for the archway to the internal roadway
- materiality for the 'mid-section' (levels 2 to 6) walls
- mesh pattern and opening size of the open mesh to the two-storey apartment communal corridor
- ST01 (Sandstone block cladding)
 - o provision of details, including cladding panel sizes, to confirm how the curved plinth column corners are achieved
- RF01 (coloured concrete maroon)
 - o method of colouring of concrete, with consideration given to high-quality integral finishes
 - o provision of the material sample, noting the submitted board includes rendered finish as per the previous selection
- PF02 (painted steel white)
 - o locations to be provided on elevations
- CL01 (blackened steel finish)
 - locations to be provided on elevations

o core material, noting the supplied sample is a solid steel plate.

In addition to the above, we also recommend clarification provided regarding the proposed method (such as tank location) of 34kL on-site stormwater detention.


